This matter is before the North Carolina Board of Pharmacy (the Board), pursuant to 21 North Carolina Administrative Code 46.2008, and with the consent of Renae A. Bausley (Respondent Pharmacist) and CVS/pharmacy, Permit #7162 (Respondent Pharmacy) to consider the entry of a Consent Order in lieu of an Administrative hearing.

Respondent Pharmacy, represented by CVS Regional Healthcare Manager Mike Cauthen, met with Board member L. Stan Haywood and Board staff in a pre-hearing conference on February 28, 2001, at the Board's office, 22 South Main Ave., Suite 102, Newton, NC. Respondent Pharmacist attended the conference via telephone communications. At that conference, Board Investigator Ken Wilkins summarized the findings of his investigation into a complaint filed by Catherine Winchester. Based on the information supplied by Mr. Wilkins and statements by the Respondents, the Board makes the following:

FINDINGS OF FACT

- 1. License #13635 was issued to Respondent Pharmacist on September 17, 1996, and renewed through the current year. Permit #7162 was issued to Respondent Pharmacy on July 20, 1998, and renewed through the current year.
- 2. At all times relevant to this Order, Respondent Pharmacist was engaged in the practice of pharmacy at Respondent Pharmacy, which is located at 3440 Wilkinson Blvd., Charlotte, NC, 28208.
- 3. On February 16, 2000, Respondent Pharmacist dispensed Isosorbide 60mg to Susan Hemphill, mother of the complainant, on a prescription order for Isosorbide 30mgs.
- 4. Patient Hemphill did not ingest any of the incorrect medication.

5. Records on file at Respondent Pharmacy indicate that pharmacist counseling was offered, but declined by the person receiving the prescription order.

6. A total of 195 prescriptions were dispensed by Respondent Pharmacist on the date the error was committed.

CONCLUSIONS OF LAW

Respondent Pharmacist and Respondent Pharmacy admit that the conduct in this matter constitutes sufficient grounds for disciplinary action on the license and the permit under GS 90-85.38(a) (6), (7) & (9).

The Respondents waive any further Findings of Fact and Conclusions of Law in this matter.

Based on the foregoing, and with the consent of the Respondent, IT IS THEREFORE THE

ORDER OF THE BOARD

That Respondent Pharmacist be reprimanded for her actions in this matter.

That Respondent Pharmacy be reprimanded for the actions of Respondent Pharmacist on a date when the pharmacist dispensed more than 150 prescriptions.

That Respondent Pharmacist and Respondent Pharmacy shall violate no laws governing the practice of pharmacy or the distribution of drugs.

That Respondent Pharmacist and Respondent Pharmacy shall violate no rules of the Board.
