THIS MATTER came on for consideration at a prehearing conference (hereinafter, "conference") pursuant to 21 N.C.A.C. 46.2008. This conference was scheduled for September 19, 2010 and, after appropriate notice, was heard on that day at the office of the North Carolina Board of Pharmacy (hereinafter, "Board") by Board member E. Lazelle Marks. Board Counsel and members of the Board's investigative and legal staff were present at this conference. Mr. Coaxum was informed of his right to be present at the conference, in person, and waived that right.

FINDINGS OF FACT

1. On August 7, 2008, Respondent Anthony M. Coaxum was granted license number 19944 by the North Carolina Board of Pharmacy by examination. Respondent also was granted a license by the South Carolina Board of Pharmacy.
2. Respondent subsequently practiced pharmacy in South Carolina.
3. On June 16, 2011, Respondent entered into a Consent Agreement with the South Carolina Board of Pharmacy following an investigation by the South Carolina Board of Pharmacy into activities that Respondent undertook while practicing in South Carolina.
4. The findings of fact and conclusions of law in the Consent Agreement are incorporated herein by reference, and Respondent admits and agrees to those findings of fact and conclusions of law.

5. The Consent Agreement provided for an indefinite suspension of Respondent's South Carolina license, which was stayed for a period of two years, upon certain conditions.

CONCLUSIONS OF LAW

Based on the above findings, the Board concludes as a matter of law:

1. Respondent Anthony M. Coaxum violated N.C. Gen. Stat. § 90-85.38(a)(6).
2. Respondent admits that the conduct in this matter constitutes sufficient grounds for disciplinary action on his license under N.C. Gen. Stat. § 90-85.38.

Based upon the foregoing, and with the consent of the parties, IT IS THEREFORE ORDERED that the license of Respondent Anthony M. Coaxum is hereby SUSPENDED INDEFINITELY, which suspension shall be stayed until June 16, 2013, upon the following conditions:

1. Respondent shall not serve as the pharmacist-manager of any pharmacy;
2. Respondent must seek professional guidance pertaining to robbery concerns while on the job as a pharmacist and must continue as indicated by such person, and he must do so to the satisfaction of the South Carolina Board of Pharmacy;
3. Respondent shall maintain full compliance with the South Carolina Board of Pharmacy's Consent Agreement, as well as this Consent Order;
4. Respondent shall cooperate with the Board, its attorneys, investigators and other representatives in any investigation and compliance with the provisions of this Consent Order;

5. Respondent shall violate no laws governing the practice of pharmacy or the distribution of devices or medical equipment;
6. Respondent shall violate no rules and regulations of the Board;
7. Respondent shall promptly advise the Board of any changes in address, employer or practice standards, as well as any other factors affecting compliance with this Consent Order; and
8. Respondent shall complete the continuing education course provided for in the Consent Agreement. The contact hours received for the continuing education course required by the Consent Agreement will not be computed in the calculation of total contact hours required for licensure or renewal in North Carolina.

If Respondent fails to comply with any terms or conditions of this Order, Respondent may be subject to additional disciplinary action by the Board.
