RPh. Scott Dinkins was issued pharmacist license number 07432, by the North Carolina Board of Pharmacy on July 25, 1980, and was reinstated in April 4, 1996.

RPh. Dinkins admits that while employed as a pharmacist at Indian Trail Pharmacy, #02670, located at 106 Indian Trail Rd. South Indian Trail, North Carolina, he has committed acts that give the North Carolina Board Pharmacy sufficient cause to revoke his pharmacist license. Considering that, RPh. Dinkins voluntarily surrenders his license as a Pharmacist in North Carolina.

RPh. Dinkins waives any further findings with respect to this matter. The surrender of the registration is made voluntarily and without pressure, coercion, or the threat of force being made against him.

RPh. Dinkins understands and accepts that he is not to be present in a pharmacy setting unless he has a valid prescription from a treating physician and/or RPh. Dinkins understands and accepts that he is not to work as a pharmacist in the state of North Carolina unless the license is reinstated by the Board following a formal hearing. It is RPh. Dinkins' responsibility to petition the Board for a hearing if he wishes to have the matter considered. Further, there is no presumption, guarantee or other implication intended within this document that the Board will reinstate the license. The decision would be made by the Board based on consideration of all available evidence presented at the time of the formal hearing.
