**MODIFICATION OF ORDER
CONCERNING REINSTATEMENT
OF LICENSE**

THIS MATTER came on for hearing upon request of George Scott Goodwyn (“Petitioner”) for a modification of a June 21, 2005 Board order. Petitioner requested that the Board modify a restriction on his license contained in that order that prohibits Petitioner from practicing as a pharmacist more than forty (40) hours per week on average. Petitioner also requested that the Board modify a provision of that order concerning employment reports to North Carolina Pharmacist Recovery Network (“NCPRN”). Petitioner’s request was heard on September 21, 2010 by the North Carolina Board of Pharmacy (“Board”) located at 6015 Farrington Rd., Suite 201, Chapel Hill, North Carolina. Board members Chater, Dennis, McLaughlin, Chesson, Minton, and Marks heard this matter. After receiving evidence, hearing testimony, and adjudging the credibility of the witnesses, the Board makes the following:

FINDINGS OF FACT

1. NCPRN Executive Director Mary Christine Parks testified that modifying Petitioner’s order to allow him to practice pharmacy for up to fifty (50) hours per week, on average, posed no significant clinical threat to Petitioner’s continued substance abuse recovery.
2. Ms. Parks further testified that NCPRN could more easily monitor Petitioner’s compliance with this hours restriction if his order were modified to require Petitioner’s monthly submission of a work schedule to NCPRN.

3. Ms. Parks further testified Petitioner has complied with his NCPRN monitoring and treatment obligations.

CONCLUSIONS OF LAW

Petitioner has demonstrated a period of successful recovery and compliance with his NCPRN contract. The Board, in its discretion, concludes that a modification of the June 21, 2005 Order is appropriate.

IT IS THEREFORE ORDERED that Petitioner's request is **GRANTED**.

Paragraph 6 of the June 21, 2005 Order stating "Petitioner may not work as a pharmacist on the average, more than of [sic] 40 hours per week" is modified.

Petitioner shall not practice pharmacy more than fifty (50) hours per week on average.


Paragraph 8 of the June 21, 2005 Order stating "Petitioner's immediate supervisor is required to submit to PRN a quarterly report on the stores [sic] volume, staffing and general working conditions of the practice site where Petitioner is employed" is modified.

Petitioner shall submit to NCPRN each month a schedule and description of his upcoming pharmacy practice work.


