CONSENT ORDER

THIS MATTER came on to be considered at a prehearing conference (hereinafter, "Conference") before a member of the North Carolina Board of Pharmacy (hereinafter, "Board") pursuant to 21 N.C.A.C. 46 .2008. This Conference was scheduled for January 19, 2015 and, after appropriate notice, was heard on that day by Board President Robert J. McLaughlin, Jr. at the office of the Board. Respondent Solon S. Minton (hereinafter "Respondent" or "Minton") was present and represented by counsel Michael C. Allen. Counsel Clinton R. Pinyan represented the Board. Members of the Board's investigative staff and related respondents were also present at the Conference.

Respondent has agreed to waive a formal hearing in the above-referenced matter. Both parties stipulate and agree to the findings of fact and conclusions of law recited herein and to the order of discipline imposed. Respondent also stipulates that he waives his right to appeal this Consent Order or challenge in any way the sufficiency of the findings of this Order by his consent. Based upon the consent of the parties, the Board hereby enters the following:

FINDINGS OF FACT

1. The North Carolina Board of Pharmacy is a body duly organized under the laws of North Carolina and is the proper body for this proceeding under the authority granted it in

Chapter 90 of the General Statutes of North Carolina, and the rules and regulations promulgated thereunder.

2. Respondent Solon S. Minton is, and was at all relevant times referred to herein, the holder of License No. 5027 and subject to the rules and regulations of the North Carolina Board of Pharmacy and the laws of the State of North Carolina. Between April 30, 2014 and June 4, 2014, he was pharmacist-manager of Aeroflow, Inc., located at 3165 Sweeten Creek Road, Suite 101, Asheville, North Carolina (Permit No. 12185, as successor to 11050) (“the Pharmacy” or “Aeroflow”).

3. At all relevant times, Aeroflow specialized primarily in mail order prescriptions and had a limited number of walk-in patients. Aeroflow did not stock or dispense controlled substances at any relevant time.

4. Between April 2014 and June 2014, Respondent regularly failed to maintain authority and control over the keys and security of the pharmacy and, on selected occasions, permitted technicians to be present in the pharmacy without a pharmacist. Respondent thus failed to exercise the required supervision over technicians and to assure that prescription drugs were safe and secure within the pharmacy.

5. Between April 2014 and June 2014, under Respondent’s supervision, Aeroflow operated an internet pharmacy (fetchrx.com) that was not VIPPS certified. Aeroflow’s website, fetchrx.com, further represented to the public that Aeroflow was licensed to ship prescription medications to a number of states in which it did not hold out-of-state permits.

6. In May 2014, under Respondent’s supervision, Aeroflow dispensed approximately four prescriptions into the Commonwealth of Kentucky without a permit to ship

into that state and without Respondent being licensed in the Commonwealth of Kentucky, as required by law.

7. The Board of Pharmacy has not been presented with any evidence suggesting that any patient experienced harm, or sustained any injuries, as a result of the activities described in above Findings of Fact.

CONCLUSIONS OF LAW

1. All parties are properly before the Board, and the Board has jurisdiction over Respondent and the subject matter of this proceeding.

2. Respondent's conduct, as set out in the findings of fact and conclusions of law above, constitutes grounds for discipline pursuant to North Carolina General Statutes § 90-85.38(a)(4), (6), (7) and (9) because Respondent's acts were in violation of N.C. Gen. Stat. § 90-85.40(b) and (f); 21 N.C.A.C. 46 .1601(a)(1), (b)(3) and (4) and (d), 46 .1804(a), 46 .2502(a) and (e) and 46 .2505; Kentucky Rev. Stat. §§ 315.030 and 315.0351 and 201 KAR 2:205.

3. Respondent admits that the conduct in this matter constitutes sufficient grounds for disciplinary action on his license under North Carolina General Statutes § 90-85.38(a).

CONCLUSIONS REGARDING DISCIPLINE

Based upon the foregoing Findings of Fact and Conclusions of Law, and with the consent of the Respondent, IT IS THEREFORE ORDERED that the license of Respondent Solon S. Minton (License No. 5027) is hereby REPRIMANDED.


