THIS MATTER was heard on January, 19, 2016, by the North Carolina Board of Pharmacy (“Board”) located at 6015 Farrington Road, Suite 201, Chapel Hill, North Carolina, upon the request of Amanda Greenwood Soles (“Petitioner”) for reinstatement of her license to practice pharmacy. Board members Mixon, Day, McLaughlin, Minton, Graves, and Haywood heard this matter. After hearing the testimony of witnesses, adjudging the credibility of the witnesses, and receiving evidence, the Board makes the following:

FINDINGS OF FACT

1. On July 17, 2012, the Board issued an order reinstating Petitioner’s license to practice pharmacy #16536 with conditions (the “2012 Order”).
2. Since the 2012 Order, Petitioner has been continuously employed as a practicing pharmacist. No complaint or concern about Petitioner’s fitness to practice pharmacy has been made to the Board during that time.
3. Since the 2012 Order, Petitioner has maintained successfully a course of substance abuse treatment and monitoring under the supervision of the North Carolina Pharmacist Recovery Network (“NCPRN”). Petitioner is scheduled to complete her treatment and monitoring agreement in July 2016.
4. Petitioner asks that the Board lift two practice-based restrictions on her license to practice pharmacy found in the 2012 Order:

- “Petitioner shall not serve as pharmacist manager of any pharmacy.”
 - “Petitioner shall not serve as a preceptor of pharmacy students”
5. The 2012 Order also specifies that “Petitioner may not be employed as a pharmacist more than 32 hours per week, on the average. This limitation may be extended at the discretion of NCPRN.” But this condition will expire automatically upon Petitioner’s successful completion of her treatment and monitoring agreement in July 2016.
6. NCPRN staff testified that Petitioner’s requested modifications will not jeopardize her recovery.

CONCLUSIONS OF LAW

Petitioner has demonstrated that she remains in a period of successful recovery and compliance with her treatment and monitoring obligations. The Board, in its discretion, concludes that, with modifications to the 2012 Order, Petitioner will continue to practice pharmacy with reasonable care, safety and competence.

IT IS THEREFORE ORDERED that the conditions of Petitioner’s 2012 Order prohibiting service as a pharmacist-manager and as a preceptor of pharmacy students are lifted. Other conditions of the 2012 Order remain in effect.
