**MODIFICATION OF
ORDER REINSTATING LICENSE**

THIS MATTER came to be considered the North Carolina Board of Pharmacy (“Board”) on March 18, 2014 upon the request of Matthew Thompson (“Petitioner”) to modify the terms of a November 17, 2009 Board order reinstating his North Carolina license to practice pharmacy number 12699. Board members Minton, Marks, McLaughlin, Chesson, Day, and Mixon heard this matter. After hearing the testimony of witnesses, adjudging the credibility of the witnesses, and receiving evidence, the Board makes the following:

FINDINGS OF FACT

1. On November 17, 2009, the Board issued an Order Reinstating License to Petitioner (the “2009 Order”), who holds North Carolina pharmacist license number 12699.
2. The 2009 Order reinstated Petitioner’s license to practice pharmacy with conditions.
3. On September 18, 2012, the Board lifted Condition 4 of the 2009 Order and modified Condition 6 of the Order.
4. Petitioner asks the Board to lift Condition 3 of the 2009 Order: “Petitioner shall obtain prior approval of all employment as a pharmacist from the Board’s Executive Director.”

5. Petitioner asks the Board to lift Condition 5 of the 2009 Order: "Petitioner shall not serve as a preceptor of pharmacy students without first obtaining approval to do so from the Board's Executive Director."
6. NCPRN supports these modifications of Petitioner's 2009 Order.

CONCLUSIONS OF LAW

Petitioner has demonstrated that, with modifications to the 2009 Order, he will continue to practice pharmacy with reasonable care, safety and competence


IT IS THEREFORE ORDERED that Petitioner's 2009 Order is amended as follows:

Condition 3 is lifted. Condition 5 is lifted.

Other conditions of the 2009 Order not lifted by this modification order or the 2012 modification order remain in effect.
