**MODIFICATION OF
ORDER REINSTATING LICENSE**

THIS MATTER came to be considered the North Carolina Board of Pharmacy (“Board”) on September 18, 2012 upon the request of Matthew Thompson (“Petitioner”) to modify the terms of a November 17, 2009 Board order reinstating his North Carolina license to practice pharmacy number 12699. Board members Minton, Marks, Chesson, Day, and Mixon heard this matter. After hearing the testimony of witnesses, adjudging the credibility of the witnesses, and receiving evidence, the Board makes the following:

FINDINGS OF FACT

1. On November 17, 2009, the Board issued an Order Reinstating License to Petitioner (the “2009 Order”), who holds North Carolina pharmacist license number 12699.
2. The 2009 Order reinstated Petitioner’s license to practice pharmacy with conditions.
3. Petitioner asks the Board to lift Condition 4 of the 2009, which prohibits Petitioner from serving as a pharmacist manager of any pharmacy.
4. Petitioner asks the Board to lift or modify Condition 6 of the 2009 Order, which states:

Petitioner may not be employed as a pharmacist more than 30 hours per week.

This limitation may, at any time, be extended to 40 hours per week, on average, at the discretion of [North Carolina Pharmacist Recovery Network (“NCPRN”)].

5. NCPRN supports this modification of Petitioner’s 2009 Order.

CONCLUSIONS OF LAW

Petitioner has demonstrated that, with modifications to the 2009 Order, he will continue to practice pharmacy with reasonable care, safety and competence

IT IS THEREFORE ORDERED that Petitioner’s 2009 Order is amended as follows:

Condition 4 is lifted. Petitioner may serve as a pharmacist manager.

Condition 6 is modified to state: Petitioner shall, for the duration of his NCPRN contract, comply with all NCPRN conditions on the number of hours he is employed each week as a pharmacist.

Other conditions of the 2009 Order remain in effect.


