**ORDER REINSTATING LICENSE
WITH CONDITIONS**

THIS MATTER was heard on March 18, 2014, by the North Carolina Board of Pharmacy (“Board”) located at 6015 Farrington Road, Suite 201, Chapel Hill, North Carolina, upon the request of Beth Tyndall Wilson (“Petitioner”) for reinstatement of her license to practice pharmacy. Board members Minton, Marks, McLaughlin, Chesson, Day, and Mixon heard this matter. After hearing the testimony of witnesses, adjudging the credibility of the witnesses, and receiving evidence, the Board makes the following:

FINDINGS OF FACT

1. Petitioner formerly held North Carolina license to practice pharmacy number 12451.
2. On March 6, 2013, Petitioner voluntary surrendered her license to practice pharmacy.
3. In late February 2013, Petitioner was discovered diverting fentanyl transdermal patches (a Schedule II controlled substance) from her then-place of practice for personal use.
4. After surrendering her license, from March to August 2013, Petitioner obtained successful surgical and medical treatment for a condition that had caused her chronic pain for more than 10 years.

5. Petitioner completed a 90-day inpatient substance abuse treatment program at the Pavillon Treatment Center in late October 2013.
6. Upon completion of inpatient treatment, Petitioner signed a five-year treatment and monitoring agreement with North Carolina Pharmacist Recovery Network (“NCPRN”).
7. NCPRN’s Cindy Clark testified that Petitioner has been compliant with her NCPRN treatment and monitoring obligations and that, from a clinical standpoint, Petitioner may safely resume the practice of pharmacy with appropriate conditions.
8. As a result of her diversion, Petitioner pleaded guilty to one misdemeanor count of larceny in April 2013. Petitioner was ordered to pay restitution to her then-place of practice and was placed on 12 months of unsupervised probation. Petitioner has made restitution and has been compliant with all terms of her unsupervised probation.

CONCLUSIONS OF LAW

The Board, in its discretion, concludes that Petitioner can safely resume the practice of pharmacy with the conditions stated below.

IT IS THEREFORE ORDERED that Petitioner’s license to practice pharmacy is **REINSTATED, SUBJECT TO THE FOLLOWING CONDITIONS:**

1. Petitioner shall complete an Application to Reinstate a Lapsed or Inactive License and pay the appropriate fee.
2. As part of the Application to Reinstate a Lapsed or Inactive License, Petitioner shall provide proof that she has obtained fifteen (15) hours of


continuing education, eight (8) of which must be live or contact hours.

These hours represent the continuing education obligation Petitioner would have been required to meet to renew her pharmacy license for 2014.

3. Petitioner shall successfully complete her NCPRN treatment and monitoring agreement.
4. Petitioner may not be employed as a pharmacist more than a number of hours per week determined by NCPRN to be clinically appropriate.
5. Petitioner may not serve as a pharmacist-manager.
6. Petitioner may not serve as a preceptor of pharmacy students. If NCPRN determines that Petitioner's serving as a preceptor would not jeopardize her substance abuse recovery program, it may so inform the Board's Executive Director, who is authorized to lift this restriction if and when appropriate to do so.
7. Petitioner shall comply with all terms of her plea agreement.
8. Petitioner shall violate no laws governing the practice of pharmacy or the distribution of drugs.
9. Petitioner shall violate no rules or regulations of the Board.
10. If Petitioner fails to comply with any term or condition of this Order, she may be subject to additional disciplinary action by the Board.
