Pamela Beasley Winchester was issued Pharmacist License No. 17533, by the North Carolina Board of Pharmacy on January 14, 2005.

Ms. Winchester admits that while employed with Walgreens Pharmacy, Permit No. 16103, located on Highway 19 and Slope, Bryson City, North Carolina she has committed acts that give the North Carolina Board Pharmacy sufficient cause to revoke her pharmacist license. Considering that, Ms. Winchester voluntarily surrenders her license as a Pharmacist in North Carolina.

Ms. Winchester waives any further findings with respect to this matter. The surrender of the license is made voluntarily and without pressure, coercion, or the threat of force being made against her.

Ms. Winchester understands and accepts that she is not to be present in a pharmacy setting unless she has a valid prescription from a treating physician. Ms. Winchester also understands and accepts that she is not to work as a pharmacist in the state of North Carolina unless the license is reinstated by the Board following a formal hearing.

Ms. Winchester understands and accepts that, at any point in the future, she may petition for reinstatement by submitting a request to the Board of Pharmacy, in writing. Upon a request for reinstatement, the Board will determine within sixty (60) days when it will schedule a hearing on the request for reinstatement. There is no presumption, guarantee or other implication

intended within this document that the Board will reinstate the license. The decision will be made by the Board based on consideration of all available evidence presented at a formal hearing before the Board. The license will not be returned until and unless the Board issues a reinstatement order after any formal hearing.
