Bobby Dishon was issued Technician registration number 24083, by the North Carolina Board of Pharmacy on October 2, 2008.

Ms. Dishon admits that while employed as a pharmacy technician at CVS Pharmacy, 1080 Hendersonville Road, North Carolina, she has committed acts that give the North Carolina Board Pharmacy sufficient cause to revoke her technician registration. Considering that, Ms. Dishon voluntarily surrenders her registration as a Pharmacy Technician in North Carolina.

Ms. Dishon waives any further findings with respect to this matter. The surrender of the registration is made voluntarily and without pressure, coercion, or the threat of force being made against her.

**Ms. Dishon understands and accepts that she is not to be present in a pharmacy setting unless she has a valid prescription from a treating physician. Ms. Dishon also understands and accepts that she is not to work as a pharmacy technician in the state of North Carolina unless the registration is reinstated by the Board following a formal hearing.**


Ms. Dishon understands and accepts that, at any point in the future, she may petition for reinstatement by submitting a request to the Board of Pharmacy, in writing. Upon a request for reinstatement, the Board will determine within sixty (60) days when it will schedule a hearing on the request for reinstatement. There is no presumption, guarantee or other implication intended within this document that the Board will reinstate the registration. The decision will be made by the Board based on consideration of all available evidence presented at a formal hearing before the Board. The registration will not be returned until and unless the Board issues a reinstatement order after any formal hearing.
