Item 1110 - DME News

The Health Care Financing Administration (HCFA) recently gave clarification to the new supplier standards. There was concern on the part of the Durable Medical Equipment (DME) Subcommittee that DME providers who work out of their homes were no longer in compliance. But after speaking with HCFA, the understanding is that the company is in compliance as long as the facility contains adequate space for equipment and records; it is accessible to clients during reasonable business hours; the hours of operation are posted; and a visible business sign is displayed. The Board inspectors will closely look at any providers who operate out of their homes to ensure that these rules are followed.

Secondly, there are still questions concerning the reuse of continuous positive airway pressure masks. After a lengthy discussion on the matter, the committee adopted a policy as follows: DME Providers should follow the manufacturer's recommendations regarding the use of nasal masks on more than on patient. Once properly fitted, a mask becomes the property of the patient and should not be returned to stock for use on another patient.

Board inspectors would like to remind everyone to review and update their disaster plans as well as policies and procedures; make sure that employees are following those policies and procedures.

Item 1111 – DEA Numbers for Midlevel Practitioners

The question has arisen of the necessity for midlevel practitioners (physician assistants, nurse practitioners, and certified nurse midwives) to obtain Drug Enforcement Administration (DEA) numbers in order to comply with the state law on prescribing information on prescriptions. The North Carolina Department of Agriculture has jurisdiction

over this issue since the requirement for a DEA number on prescription documents is in the state Food, Drug and Cosmetic Act.

In response to a specific question, Bruce Williams, the director of the Food and Drug Protection Division of the Department of Agriculture, stated in a letter to the Board that the agency's staff opinion is that the DEA number would be required to be shown only if the prescribed drug was a controlled substance. This should clarify any questions on this issue.

Item 1112 - Board Member Elections

Ballots for two positions on the Board of Pharmacy beginning in the spring of 2002 were mailed earlier this month. If you have not voted yet, please send your ballot as soon as possible.

The next election will be in the Spring of 2004 for two positions open in the spring of 2005.

Item 1113 - Board Information Service

The Board plans to begin an information service soon for North Carolina licensed pharmacists. This will consist of periodic e-mail messages to convey important information such as drug recalls, advance newsletter text, and other important material such as the information recently distributed for claims on lorazepam and clorazepate. An initial message should go out soon and those who wish not to receive this information may unsubscribe in the normal way.

Item 1115 – Novel Dispensing Error

In some pharmacies it is a common practice to "borrow" products from another nearby pharmacy and return them when the wholesaler's shipment comes in. This common practice recently produced a novel dispensing error which is worthy of noting.

Pharmacy "A" borrowed drug "B" from Pharmacy "C" to dispense in Pharmacy "A." When the drug was returned to Pharmacy "C" it was drug "D" but mislabeled as drug

"B" and the pharmacist at "C" placed the container from "A" on the shelf labeled as drug "B." When a prescription at Pharmacy "C" was dispensed with drug "D" instead of drug "B" the error was discovered by the patient after dispensing.

We are unaware of any other similar error but it is worth checking products during such a borrowing arrangement.

Item 1116 - Pharmacists Save Lives

A report from the WRAL Channel 5 Web site described the story of pharmacists Paige Huston and Sylvia Stafford in Dunn.

At the end of December, a consumer eating lunch at Dunn Restaurant had chest pains and proceeded to Thomas Drugs to have her blood pressure checked. Pharmacists Stafford and Huston noticed that she was pale and administered a chewable aspirin. The patient was quoted as saying, "I'm sure what those two girls did helped save my life, and I am very grateful."

In LaGrange during the middle of January, a small child stopped breathing while her mother was in the checkout line at a grocery store. Ray Burke is the pharmacist-manager there and he, along with a registered nurse who was in the store shopping, positioned the child to assist her breathing until emergency personnel arrived at the store.

It is actions like these that cause the public to give pharmacists consistently high ratings in public service.

Item 1117 - Brand/Generic Labeling

Stacie Krick from the Wake Area Help Education Center has brought to our attention a problem that deserves pharmacists' attention.

In one case, a patient is told to increase his Lasix dose. Although he has a prescription container labeled "furosemide," none of his prescription containers had a "Lasix" label. One has a "Lanoxin" label, which he assumes he Lasix and is consumes that drug for at least one week at a high level. The patient had to spend several days in the intensive care unit receiving Digibind.

A Medicaid patient takes a prescription for Coumadin to a retail pharmacy where it is filled with Warfarin. The patient has Coumadin from a hospital labeled as the brand name and does not realize that they are the same product. He consumed both prescriptions (5 mg each), and his international normalization ration (INR) is 5.83 upon admission to the hospital.

Stacie suggests that the way to avoid these errors is to include both generic and brand names on the label. We appreciate her bringing this to our attention so we can share it with pharmacists of the state.
