President Andy Bowman called the meeting to order at 10:02 am with Board Members Ashley Duggins, Wallace Nelson, Chris Sain, and Keith Vance in attendance. Mischelle Corbin was not present due to a family emergency.

Also in attendance were Executive Director Jay Campbell, Board Counsel Clint Pinyan, Associate Executive Director Ellen Vick, Director of Inspections Krystal Stefanyk, Director of Investigations Gray Fullwood, Director of Licensing Missy Betz, Director of Operations Kristin Moore, Enforcement Manager Cindy Parham, Investigator/Inspector Brent Slaughter, Accounting Manager JP Brown, and Administrative Assistant Leslie Wilson.

Present as visitors were Joe Jordan, Heather Hughes, Colton Jones, Julianne Shytle, Kira Martin, and Christine Heath.

Ethics Statement & Welcome

President Bowman read the Ethics Statement regarding conflicts of interest. No conflicts were noted by Board members.

Consideration of Meeting Minutes

The members received the November 2023 meeting minutes and the December 7, 2023 Special Meeting minutes for review prior to the meeting. Dr. Vance moved to approve both sets of minutes. Dr. Duggins seconded. The motion passed unanimously.

Hearings

Petition to Modify Order Reinstating License, Colton Jones, License No. 27904 (*Campbell*)

On July 16, 2019, the Board reinstated Colton Jones' license to practice pharmacy #27904.

Under the terms of the 2019 reinstatement order reinstating R.Ph. Jones' license, his stayed suspension has been lifted as a result of his successful completion of his NCPHP treatment and monitoring agreement. R.Ph. Jones has also requested that the provision in the 2019 order limiting his ability to act as a pharmacist manager be lifted. NCPHP and Board staff support this modification.

Mr. Wallace moved to have the pharmacist-manager restriction lifted and the issuance of an order from the Board memorializing the lifting of the stayed suspension. Dr. Sain seconded. The motion passed unanimously with Dr. Vance abstaining.

NC Professionals Health Program

Appointment of Committee to Work with NCPHP Staff to Review Operational Needs and Resources and Make Recommendations to the Budget and Finance Committee (*Campbell*)

The Board entered into its memorandum of agreement with NCPHP, effective November 15, 2015. Given the passage of time, Board and NCPHP staff recommend forming a committee to meet to discuss NCPHP and BOP resources and needs, and to make recommendations to the Board Budget and Finance Committee for consideration during the FY 2024-25 budget planning process.

Mr. Campbell recommended forming a two-Board-member committee to work with NCPHP staff to conduct this review. He noted that Mischelle Corbin and Chris Sain are the Board's designees to the NCPHP board of directors. President Bowman agreed that it made sense to designate them as the committee and would first meet on the February 13th Committee Work Day.

Financial Reports

Accounting Manager JP Brown presented the monthly financial report. The members received the report prior to this meeting. The members reviewed and had no questions.

Licensing Report (Betz)

2024 Renewal Season

Director of Licensing Missy Betz provided a briefing on the 2024 license/permit/registration renewal season and included a comparison with 2023 renewal season. Renewal trends are consistent with previous years. Ms. Betz noted that this year there were minimal calls/emails concerning forgotten log-in information, demonstrating that changes to the recovery process put in place last year are working.

Pharmacists Licensed by Examination – January 1, 2023 – December 31, 2023

Board staff provided a list of all pharmacists licensed by exam in 2023 to be included in the January 2024 Board minutes.

Investigations and Inspections Report (Stefanyk)

Investigative Statistics (*Stefanyk*)

Krystal Stefanyk, Director of Inspections, presented the investigations report and current caseload.

<u>Inspector and Investigator Compounding Summit</u> (Stefanyk)

Ms. Stefanyk gave a registration update for the upcoming Compounding Summit.

Legislative Report (Pinyan, Campbell)

Mr. Campbell reported there were no changes in the legislative report since the retreat in November 2023.

Mr. Nelson requested that the minutes reflect the Board's recognition of, and appreciation for, the North Carolina Association of Pharmacists' legislative efforts on behalf of the pharmacy profession in the state of North Carolina. Mr. Campbell agreed with his assessment.

Rulemaking (Pinyan, Campbell)

Rulemakings in Progress:

Proposed Amendment to 21 NCAC 46.1613, Extension Period

This rulemaking in process proposes an amendment to the rule governing extensions of time for renewal requirement for certain members of the armed forces. The amendment simply adds dispensing optometrists (granted dispensing authority pursuant to SL 2023-129) to the list of covered Board of Pharmacy licensees and registrants. A public hearing was held on Monday, January 8, 2024. No one appeared to speak and no comments were received. The comment period is open through February 13, 2024. Board staff will update the members on any comments received.

Mr. Campbell and Ms. Betz are working on the dispensing optometrist registration application, and they anticipate its being ready to implement well in advance of the March 1, 2024 effective date for dispensing optometrist authority.

For Action by the Board:

Publish Proposed Amendments to 21 NCAC 46.2201, Continuing Education

As discussed at the November retreat, this proposed amendment to the continuing education requirement would allow pharmacists to carry over up to five surplus CE credits for one year. The proposed amendment reinserts language contained in Rule .2201 prior to its last amendment in 2018. Mr.

Nelson moved to publish the proposed amendment for notice and comment. Dr. Duggins seconded. The motion passed unanimously.

Publish Proposed New Rule 21 NCAC 46.2516, Emergency Closure

As discussed at the November retreat, Board members and staff have become increasingly aware of situations in which pharmacies close suddenly for staffing or other emergency reasons. These sudden closures, even when justified, can work a substantial hardship on patients who find themselves unable to obtain their prescription drugs in a timely manner. Proposed new rule .2516 would:

- (a) Confirm the pharmacist-managers statutory responsibility and authority to cease some or all of a pharmacy's operations when the PM determines that doing so is necessary to ensure safe delivery of prescription drugs and/or ensure that adequate qualified personnel are in place to properly render pharmaceutical services.
- (b) Require that the PM post conspicuous notice of the closure, anticipated resumption of services, notify the Board of the closure, and arrange for the transfer of any prescriptions at the patient's request during the time of the closure, and conspicuously notify the public of the transfer option and process.

Dr. Sain moved to publish the proposed new rule for notice and comment. Dr. Duggins seconded. The motion passed unanimously.

Committee Progress Reports

<u>Budget & Finance Committee – Duggins, Corbin, Sain (members); Campbell, Jones, Brown (staff)</u> Next anticipated meeting is in the spring to propose a FY2024-25 budget.

<u>Health-System Rules Review – Nelson, Sain (members); Campbell, Pinyan, Stefanyk, (staff).</u> The Committee convened its working group during the Board's October workday. Working Group members discussed a number of substantive issues. Good engagement and progress on a number of issues. Committee schedule to meet next on the February 13 committee workday.

<u>Patient Counseling Rule Review – Duggins, Vance, Bowman (members);</u> <u>Campbell, Pinyan (staff).</u> Board staff has drafted a preliminary discussion draft of potential amendments to the rule for the committee's consideration.

Opioid Settlement – *Corbin, Vance (members); Campbell (staff).* Appointed by President Bowman at the November retreat and tasked with liaising with the North Carolina Association of County Commissioners to educate and advise on

use of opioid settlement funds for pharmacy projects. Mr. Campbell attended an on-line seminar on the national opioid settlement and pharmacy intersection with same sponsored by the Wisconsin Pharmacy Association to gather background information and materials. He provided various background materials to the committee members, Kevin Leonard (of the NCACC), and Penny Shelton. They are meeting on January 16 to discuss process. Mr. Leonard and Mr. Campbell met on December 18. Mr. Leonard has proposed the committee meeting with NCACC stakeholders in April 2024. It was recommended convening the committee on the Board's February 13 workday to review materials, process, and substantive recommendations.

2023 Annual Retreat Recap

Mr. Campbell stated that issues covered at the retreat have been covered earlier in the meeting and he had nothing new to add. The Board agreed.

NABP Annual Meeting, May 14 – 17, 2024 Fort Worth, TX

NABP's Annual Meeting is scheduled for May 14 - 17, 2024 in Fort Worth, TX. Each year, the Board must designate a voting delegate and an alternate for the meeting's business sessions. As well, NABP provides a travel grant for one Board member from each state – typically the voting delegate. The Board agreed that Dr. Sain would be the NCBOP delegate and Mr. Campbell would assume the role of alternate.
