President Wallace Nelson called the meeting to order at 3:30pm. Board Members Andy Bowman, Mischelle Corbin, Ashley Duggins, Chris Sain, and Keith Vance were all present.

Also present were Executive Director Jay Campbell, Board Counsel Clint Pinyan, Information Technology Administrator Antoine Pryor, Enforcement Specialist Cindy Parham, Administrative Assistant Leslie Wilson, and Director of Licensing Missy Betz. Board Investigator/Inspector Brent Slaughter, Board Investigator/Inspector Christie Cutbush were available through teleconference.

President Nelson reminded the Board of the Ethics Statement regarding conflicts of interest and/or appearances of conflicts of interest of any Board member. No conflicts were noted by Board members.

Dr. Bowman moved to go into closed session to receive attorney-client communications concerning Billingsley v. NC Board of Pharmacy. Dr. Vance seconded. The motion passed with no dissenting votes.

Open session resumed on a motion from Dr. Sain, seconded by Dr. Duggins, passed unanimously. President Nelson stated that the Board approved the settlement agreement between the North Carolina Board of Pharmacy and Jilyan Austin Billingsley, License No. 26514. It was noted that Dr. Bowman, as the officer of the prehearing conference, had recused himself from the vote.

On a motion from Dr. Bowman, seconded by Dr. Duggins with no dissenting votes, the Board voted to adjourn at 3:50 pm.

## **FINDINGS OF FACT**

- 1. Between September 15, 2016 and October 18, 2022, Jilyan Austin Billingsley ("Petitioner") was the holder of license number 26514, issued by the Board.
- 2. Between September 10, 2019 and December 2, 2020, Petitioner had her prescriptions for Zolpidem 5mg and 10 mg (a schedule IV controlled substance) filled at a Walgreens pharmacy where her husband, Jay Billingsley was employed as a pharmacist.
- 3. During this period, Jay Billingsley filled 1200 dosage units of Zolpidem when Respondent had been prescribed only 420 dosage units.
- 4. When these unauthorized refills came to light, Jay Billingsley informed both Walgreens and the Board investigator that he had provided the unauthorized refills to Petitioner.
- 5. However, following the summary suspension, Petitioner provided new evidence indicating that she did not take more Zolpidem than prescribed and instead those were consumed by Jay Billingsley.
- 6. In addition, on or about February 11, 2022, Petitioner tested positive to THC. Petitioner has provided evidence that the positive result was due to consumption of CBD.
- 7. On October 18, 2022, the Board of Pharmacy summarily suspended Petitioner's license. On December 12, 2022, Petitioner requested that the summary suspension of her license be lifted.

## **CONCLUSIONS OF LAW**

Due to conflicting evidence, the Board has determined that Petitioner has not violated any laws giving rise to a basis for discipline under N.C. Gen. Stat. § 90-85.38(a). Accordingly, Petitioner's request to lift the summary suspension should be granted.

## **ORDER**

Based upon the foregoing Findings of Fact and Conclusions of Law, the Board hereby ORDERS that the summary suspension order of the license of Jilyan Austin Billingsley is hereby VACATED, the request for reinstatement is hereby GRANTED, and the license of Dr. Billingsley is hereby REINSTATED in good standing.
