<u>Proposed Amendments to 21 NCAC 46.2507 Governing Pharmacist Administration Vaccine to Conform with S.L. 2013-246</u>

Mr. Campbell presented proposed amendments to rule .2507 governing pharmacist administrations of vaccines. The revisions are required because of changes in pharmacist immunization authority in S.L. 2013-246. After discussion, on a motion from Mr. Marks, seconded by Mr. Mixon with no dissenting votes, the Board moved to accept the amendments as presented and post them for notice and comments.

# <u>Petition of Reinstatement of License to Practice Pharmacy – Beth Tyndall Wilson, License</u> #12451

RPh. Beth Tyndall Wilson, license #12451, appeared before the Board to petition for reinstatement of her pharmacist license. Ms. Wilson voluntarily surrendered her license March 6, 2013 after diverting fentanyl transdermal patches from WakeMed hospital for personal use. Ms. Wilson admitted to diverting the medication. After surrendering her license, Ms. Wilson obtained successful surgical and medical treatment for a condition that had caused her chronic pain for more than ten (10) years. Ms. Wilson entered into a five (5) year treatment program with NCPRN and completed an inpatient substance abuse assessment at Pavillon Treatment Center. Ms. Wilson, duly sworn, testified on her recovery progress. Cindy Clark, NCPRN, duly sworn, stated that NCPRN supports her request for reinstatement of her license with conditions and deemed her safe to practice.

### **Prehearing Conference**

RPh. Chris Bowen, License #07224; RPh. Eileen Guse, License #12284; RPh. Selinger; Charles Drew Medical Center, permit #06027; and Technician Ena Alghaben, registration #1742; were subjects of a prehearing conference held February 17, 2014, heard by Mrs. Day, regarding allegations that between January 2012 and May 2013, sixteen (16) unauthorized refills for non-controlled substances were dispensed to patients that did not have valid prescriptions. Also, the pharmacy's computer system was allowing one (1) employee to log-in at a station but multiple technicians and pharmacists could work there, which would be documented under the initial log-in.On June 22, 2013, Technician Ena Alghaben created a fraudulent prescription for eight (8) dosage units of Hydrocodone 5/500mg, which was called into another pharmacy. The prescription was created because Ms. Algahaben forgot to deliver a legitimate order to a patient and did not want the patient to be without their medication. Recommendation: **Staff issue a Letter of No Action** to RPh. Bowen and RPh. Guse; a **Letter of Warning with error reduction course** to Technician Alghaben; and a **Letter of Warning** to the permit.
