President Gene Minton called the meeting to order at 9:00 am with Board Members Bill Mixon, Stan Haywood, Carol Yates Day, Robert Graves, and Andy Bowman present. Ethics Statement & Welcome

President Minton read the Ethics Statement regarding any conflicts of interest and/or appearance of conflicts of interest of any Board member. No conflicts were noted by Board members.

Consideration of Minutes of the February 2017 Meeting Minutes and March 8, 2017 Conference Call

The members received the February 21, 2017 meeting minutes and the March 8, 2017 conference call meeting minutes prior to this meeting for review. It was moved by Mr. Bowman, seconded by Mr. Mixon, to approve the minutes as presented. The motion passed with no dissenting votes.

Participation in NABP's VPP Blueprint Program

At the November 15, 2016 Board meeting, Associate Executive Director Ellen Vick and Associate Director of Investigations and Inspection Krystal Brashears Stefanyk spoke to the Board regarding the possibility of entering into an agreement with National Association of Board of Pharmacy (NABP) whereby states can agree to certain responsibilities so that their inspections will be deemed to be sufficiently rigorous by other states.

There are certain requirements to be admitted in the program including inspecting high, low, and medium risk sterile compounding facilities that ship into other states every 18 months. The Board inspection policy already requires high risk sterile compounding facilities to be inspected on an annual basis. The Board 2017 pharmacy permit renewal application questions regarding sterile compounding have updated the Board's records on which permits are performing sterile compounding in North Carolina. Board staff will send a letter to those pharmacies to ascertain how many permitted sterile compounding facilities ship into other states to determine if current resources are sufficient to meet the program requirements.

After discussion, it was the consensus of the Board to have a representative from the NABP VPP Blueprint program come to the April 2017 Board meeting to speak about the program.

<u>Updated Request from the North Carolina Secretary of State – Online Drug Purchases Education</u> Campaign

At the February 2017 Board meeting, staff stated that the Office of North Carolina Secretary of State contacted Board staff regarding a campaign to educate consumers about the risk of purchasing prescription drugs from Internet-based sites. The campaign focused on a drug discount card program, "Save on My Meds".

After discussion, it was the consensus of the Board that endorsing a program that recommended participating pharmacies in a discount program would be outside the Board's statutory mission. Mr. Campbell noted that the Secretary of State's office was revising the campaign focus and materials and that he would bring any revised campaign back to the members for further consideration.

The Office of the Secretary of State has contacted the staff again with revised campaign material that eliminated the previous marketing program.

After discussion, it was the consensus of the Board that more information regarding the campaign would be needed before the members could endorse the program. The Board directed Mr. Campbell to contact the Secretary of State to set a meeting with Board staff to discuss the program further.

Pharmacies Selling Cannabidiol Products

In 2014, the General Assembly authorized neurologists to "approve of dispensing" of hemp extract/cannabidiol product, acquired from another jurisdiction, to caregivers of patients with intractable epilepsy. Investigative staff has encountered some pharmacies who staff believes have misunderstood the new law regarding cannabidiol products and have advertised the sale of hemp extract in violations of laws governing marijuana.

After discussion, it was the consensus of the Board to direct Mr. Campbell to write a FAQ to clarify the new law regarding cannabidiol products and post it on the Board website.

Rule Making

Mr. Campbell stated that the amendments to the election rules, the examination rules, and the e-Profile rule have been sent to the Rules review committee for approval.

Mr. Campbell presented a draft FAQ's on the new continuing education rule amendments to be posted on the website for Board's approval. It was the consensus of the Board to approve the FAQ's as presented for publication.

Decennial Rule Review

North Carolina law requires each agency to undertake a periodic review of each of the rules that it has passed. At the February 2017 Board meeting, on a motion from Mr. Graves, seconded by Mr. Haywood with no dissenting votes, the Board accepted the initial classification of Board rules presented by staff as "unnecessary", "necessary without substantive public interest", or "necessary with substantive public interest" and directed staff to publish them for comment. Board Counsel Clint Pinyan stated that the rules have been published to the Board's website for comment.

Legislative Update

S.175/H.243, Strengthen Opioid Misuse Prevention (STOP) Act

This bill is a mixture of various provisions intended to improve North Carolina's response to the opioid abuse public health crisis. Among other provisions, the bill limits practitioners to five-day and seven-day starter prescriptions for all controlled substances for treatment of "acute pain" and "post-operative pain", respectively.

After discussion, the Board instructed Mr. Campbell to contact the authors of the bill to clarify how a pharmacist would determine if a starter prescription is for "acute pain" or "post-operative pain".

H.142, Increase Oversight of OLBs

This bill's purpose is to provide some additional antitrust immunity security for occupational licensing boards by clarifying statutory authority for occupational licensing boards to enjoin unlicensed practice and the procedures for doing so.

S.104, Require Criminal Background Check/Pharmacist Licensure

This bill gives the Board authority to use third-party vendors to conduct on-line criminal background check for license applicants.

Financial Report

Krystal Smith, Accounting Manager, presented the February 2017 financial report to the Board.

Investigations and Inspections Report

Joshua Kohler, Director of Investigations and Inspection, presented the March 2017 investigative report.

Further Discussion on Board Retreat Planning

After discussion, it was the consensus of the Board to hold the 2017 Board Retreat September 28 - 29, 2017 in Pinehurst, NC.

<u>Update on 2018 NABP District III Meeting Planning</u>

The Board is scheduled to hold the 2018 NABP District III meeting in August 2018. After discussion, it was the consensus of the Board for staff to look at venues in Asheville, NC to hold the District III meeting.

Reports to the Board

Mr. Campbell stated that he is working to schedule the next Tele-Pharmacy Committee meeting.

No other reports were presented.
