Ethics Statement & Welcome

President Vance read the Ethics Statement regarding conflicts of interest and/or appearances of conflicts of interest of any Board member. No conflicts were noted by Board members.

Consideration of Minutes of the May 2019 Board Meeting

The members received the May 21, 2019 meeting minutes prior to this meeting for review. It was moved by Dr. Bowman, seconded by Mr. Graves, to approve the minutes as submitted. The motion passed with no dissenting votes.

Opioid Crisis Response Committee Update

Board Member Ashley Duggins updated the Board on the Opioid Crisis Response Committee. Ms. Duggins stated that the Board has partnered with MorePowerfulNC.org and is in the process of producing labels to place on opioid prescription bottles. The labels will be provided to North Carolina pharmacies and will contain information on MorePowerfulNC.org and ways to fight opioid addiction.

Board Member Election for Northeastern and Central District Seats

Director of Operations Kristin Moore and IT Manager Antoine Pryor updated the Board on the voting process for the Northeastern and Central District Election that will be held during the 2020 renewal season (November 1, 2019 – February 28, 2020). They demonstrated the new online election through the Board's Gateway system. All active pharmacist residing in North Carolina will be eligible to vote through the Board Gateway during the 2020 renewal period.

Report from the FDA Public Meeting on CBD Products

Board Members Ashley Duggins and Robert Graves updated the Board on the FDA public meeting on CBD products held on May 31, 2019. Ms. Duggins stated that there were over 80 speakers from all types of industry including physicians, manufacturers, and regulators. The consensus of the speakers was the need for more CBD product regulations.

Legislative Update

Mr. Campbell updated the Board on several legislative matters including:

S.546, Opioid Epidemic Response Act. The bill requires: (a) to report gabapentin and naloxone prescriptions to the NC CSRS; (b) require prescribers who prescribe a "targeted controlled substance" (i.e., an opioid) or a benzodiazepine to review CSRS data for the patient prior to prescribing and every three months afterward (a modification of the STOP Act requirement to review prior to prescribing an opioid); (c) creation of a State Opioid Treatment Authority charged with reviewing applications to open an opioid treatment program (OTP) - the SOTA would have broad rulemaking authority to set standards for OTP. This bill did not survive crossover.

Mr. Campbell stated that the Department of Health and Human Services (DHHS) has asked the Board to relay any concerns that it has with the bill. He provided two summary documents provided by DHHS for the Board members to review.

After discussion, it was the consensus of the Board to direct staff to relay to DHHS that they do not have substantive concerns regarding bill.

The Board adjourned for a break at 11:08am and resumed open session at 11:23am.

Financials

Because the June 2019 Board meeting was held one week prior to its original schedule date, there was no financial report presented.

Krystal Stefanyk, Director of Inspections, presented the June 2019 investigative report.

Prehearing Conference

Staff Issues Letters of Warning

RPh. Thomas A. Luthy, license #18500; and Main Street Pharmacy, permit #09053 were subjects of a pre-hearing conference held on Monday, May 20, 2019, heard by Mr. Mixon regarding the following case:

On or about May 19, 2016, pharmacy staff improperly dispensed Metformin 1000mg tablets in such a way that an elderly patient ingested a full 1000mg tablet twice per day.

The investigation determined patient Smith was prescribed Metformin 1000mg, #60, with instructions, "Take ½ tablet two times a day." Main Street Pharmacy and RPh. Luthy improperly packaged the Metformin so as patient Smith would ingest a full 1000mg tablet two times per day. Additionally, Main Street Pharmacy and RPh. Luthy as pharmacist-manager, allowed pharmacists to supervise more technicians than permitted by law, which increased the risk of error.

After hearing all the evidence presented and based on the standards established by the Board, Mr. Mixon proposed that staff issues **LETTERS OF WARNING** to RPh. Luthy and the permit.

Staff Issues Letters of Warning

RPh. Gregory B. West, license #06625; RPh. John H. Higgins, license #10946; RPh. R. Andrew Hollifield, license #07356; Technician Susan C. Harton, registration #12334; and Smith's Drug of Forest City, Inc., permit #07515, were subject of a prehearing conference a pre-hearing conference held on Monday, May 20, 2019, heard by Mr. Mixon regarding the following case:

On or about March 16, 2016, pharmacy staff improperly dispensed Morphine with a pump set to 10mg/hr. instead of 5mg/hr.

The investigation determined that RPh. West not only dispensed the Morphine pump, but also verified the infusion pump without having adequate knowledge to do so. Furthermore, the pump was labeled as being filled by RPh. Higgins when RPh. West was the dispensing pharmacist. RPh. West along with RPh. Hollifield and Technician Harton participated in creating and maintaining inaccurate and inadequate records of the compound. These actions occurred all while under the supervision of RPh. Higgins, Pharmacist-Manager.

After hearing all the evidence presented and based on the standards established by the Board, Mr. Mixon proposed that staff issues **LETTERS OF WARNING** to RPh. West, RPh. Hollifield, RPh. Higgins, Technician Harton, and the permit
