The members received the June 18, 2013 meeting minutes prior to this meeting for review. It was moved by Dr. Chesson and seconded by Mr. McLaughlin to accept the Minutes as submitted. The motion passed with no dissenting votes.

Consideration of Request for Reinstatement – RPh. Scott Crawford, License #10060

RPh. Scott Crawford, license #10060, appeared before the Board to request reinstatement of his pharmacist license. Mr. Crawford voluntarily surrendered his license November 12, 2012 after testing positive for marijuana while working at Mission Cancer/Infusion Services Pharmacy. His employment was later terminated. Mr. Crawford, duly sworn, testified on his recovery progress. Cindy Clark, NCPRN, duly sworn, testified on Mr. Crawford's recovery and stated that NCPRN

advocates for his reinstatement with certain conditions. Mr. Campbell stated that staff has no opposition to reinstatement with conditions.

After presentation of evidence and testimony, on a motion from Mr. Mixon, seconded Dr. Chesson with no dissenting votes, the Board approved Mr. Crawford's reinstatement with conditions.

A copy of the Order Reinstating License with Conditions can be found elsewhere in the Minutes and is incorporated by reference herein.

The Board recessed for a break at 9:55am and resumed open session at 10:15am.

Consideration of Request for Reinstatement – RPh. Anjali Laroia, License #18615

RPh. Anjali Laroia, license #18615, appeared before the Board to request reinstatement of her pharmacist license. Mrs. Laroia voluntarily surrendered her pharmacist license September 13, 2012 after suffering from a seizure at work which may have been contributed to by abuse of opiates. Mrs. Laroia, duly sworn, testified on her substance abuse problems and her recovery progress. Cindy Clark, NCPRN, duly sworn, testified on Ms. Laroia's recovery progress and stated that NCPRN supports reinstatement of her license with conditions. Mr. Campbell stated that staff has no objections to reinstatement with certain conditions.

After presentation of evidence and testimony, on a motion from Mr. McLaughlin, seconded by Mrs. Day with no dissenting votes, the Board moved to reinstate Mrs. Laroia's pharmacist license with conditions.

Legislative Report

2013 North Carolina General Assembly Session

S.222 – The bill has passed both chambers of the North Carolina legislature and has been signed into law by the Governor. The bill revises the Controlled Substance Reporting System (CSRS). The bill has a provision that would require the CSRS to notify licensing boards when they identify a licensee who has committed an infraction. The statute directs licensing boards to set rules for criteria to submit these reports. Mr. Campbell will look further into the requirements and report to the Board at the September meeting.

H.832 – The bill has passed both chambers and has been signed into law by the Governor. The bill allows an "immunizing pharmacist" to administer any CDC recommended vaccine to a patient age 18 or up upon a prescription order. It allows administration of pneumococcal, zoster, Hep B, meningococcol, tetanus booster, TDAP, flu pursuant to standing orders or protocols. The effective date of the law is October 1, 2013 if six organizations which have been tasked by the statute to formulate minimum safety protocols which will be submitted to Medical, Nursing, and Pharmacy boards by

that date. If the deadline is not met, then the task will be moved to the Immunization Branch to formulate the safety protocols by January 1, 2014.

H.675 – Allows certified technicians to register with the Board of Pharmacy independent of specific technician employment and makes clear that PTCB certification satisfies statutory training requirements. It also adds additional procedural protections for pharmacies being audited and places a six-month "expiration date" on Schedule II prescriptions. Mr. Campbell knows of no opposition to the bill and staff is anticipating/working on any changes that will need to be made to technician registration procedure.

Federal Legislation

S959 – The bill, introduced in the U.S. Senate, states that if a pharmacy compounds sterile products, compounds non-patient specific prescriptions, and ships compounded medications interstate it would be considered a "compounding manufacturer" and would be regulated by the FDA. Repackaging of sterile single dose vial products would also make a facility a "compounding manufacturer". A compounding manufacturer would also be prohibited by federal law from operating as a pharmacy. This bill has been submitted to the Senate Health Committee for review.

H-2186 – A compounding bill has been introduced in the U.S. House of Representatives. The bill is similar to the Senate bill, but would not prohibit a compounding manufacturer from operating as a pharmacy. The House bill is also more restrictive than the Senate bill on what may be compounded. The bill has been introduced to the House but has not been submitted to committee.

Continuing Report on Activities of the Pharmacy Compounding Working Group

At the May 2013 Board Meeting, it was the consensus of the Board that Mr. Campbell draft a possible rule change to include USB 797 and 795 standards. At the June 2013 Board Meeting the Board approved a compounding working group subgroup to meet with him and Rob Patchett to review and make recommendations to the proposed rule change draft. The Board approved Bill Mixon, Ken Latta, and Gigi Davidson to make up the subgroup. Mr. Campbell stated that the subgroup has not met yet because of inclement weather problems but they do plan to meet on Thursday, July 11th.

<u>Licensure Eligibility Status of Graduates of a School of Pharmacy Holding "Candidate Accreditation Status"</u>

There are number of new pharmacy schools opening across the country. Board rules require that, to be eligible for licensure, a candidate must have graduated from an accredited school of pharmacy. There can be a delay between the first graduating class and full accreditation. Staff queried the Board whether, in such cases as a delay before full accreditation, "candidate accreditation" status is sufficient to meet eligibility requirements.

After discussion, on a motion from Dr. Chesson, seconded by Mr. McLaughlin with no dissenting votes, the Board deemed "candidate accreditation" to satisfy Board rule.

Financial Report

Gail Brantley, Financial and Administrative Services Director, presented the June 2013 financial statistics to the Board.

Approval of Audit Services for Fiscal Year 2013, 2014, and 2015

On a motion from Mr. Mixon, seconded by Dr. Chesson with no dissenting votes, the Board approved an audit services contract for three years with Furr & Newell.

Report on Visit from State Auditor

The NC State Audit office conducted a financial audit and a Chapter 93B compliance audit of the Board. The final audit report has not been presented to staff as of the July 2013 Board meeting.

Investigative Statistics

Director of Investigations Karen Matthew presented the investigative report for July 2013.

Mr. Campbell reminded the Board members that the MALTAGON meeting, hosted by the NC Board, will be held September 29th – October 2nd, 2013 in Asheville, NC.

Pharmacy Leaders' Forum Planning

Mr. Campbell reminded Board members that the 2013 Pharmacy Leaders' Forum will be held September 20, 2013 in Greensboro, NC.

Filing of Board's Annual Report as Required by Chapter 93B on the North Carolina General Statutes

Mr. Campbell stated that the 2011 - 2012 NC Board of Pharmacy Annual report has been filed with the state and presented a copy to each Board member.

Prehearing Conference

Staff Issues Letters of Caution, Warning and No Action

RPh. Michael Nazor, license #21601; RPh. Robert Fountain, license #05697; and CVS Pharmacy, permit #10805, were subjects of a prehearing conference held June 17, 2013, heard by Mr. Mixon, regarding allegation that a patient was dispensed Clindamycin 75mg/5ml without being reconstituted. Patient ingested at least seven (7) doses of the powder. The pharmacy also failed to offer counseling. Recommendation: **Staff Issues Letter of Caution** to permit; **Staff Issues Letter of Warning** to RPh. Nazor; and **Staff Issues Letter of No Action** to RPh. Fountain.

Staff Issues Letters of Caution and No Action

RPh. John Meehan, license #21353; RPh. Ronda Cingolani, license #22236; and Walgreens, permit #10892, were subjects of a prehearing conference held June 17, 2013, heard by Mr. Mixon, regarding allegations of a patient being dispensed Methadone 5mg along with the prescribed Morphine 100mg/5ml. The patient ingested three (3) doses of the Methadone before the error was discovered by hospice nurse. Recommendation: **Staff Issues a Letter of Caution** to permit and **Staff Issues Letters of Caution** to RPh. Meehan and RPh. Cingolani.

Staff Issues Letters of Concern and Cautionu

RPh. Gregory Shull, license #07972, and Family Medicine Pharmacy, license #09028, were subjects of a prehearing conference held June 17, 2013, heard by Mr. Mixon, regarding allegations of violations found during a November 27, 2012 inspection. Recommendation: **Staff Issues a Letter of Concern** to permit and **Staff Issues a Letter of No Action** to RPh. Shull.

Staff Issues Letters of Concern, Caution, and No Actionu

RPh. Jameeka Carrington, license #18922; RPh. Selassie Hayibor, license #18158; and Walgreens, permit #07533, were subjects of a prehearing conference held June 17, 2013, heard by Mr. Mixon, regarding allegations of a patient dispensed, in the same vial, 100 dosage units of Morphine IR 30mg along with 140 tablets of prescribed Methadone 10mg. Patient had been prescribed 240 dosage units of Methadone 10mg and did not have a prescription for Morphine IR 30mg. Patient ingested an unknown amount of the incorrect medication. Recommendation: **Staff Issues a Letter of Concern** to RPh. Carrington; **Staff Issues a Letter of Caution** to permit; and **Staff Issues a Letter of No Action** to RPh. Hayibor.
