Ethics Statement & Welcome

Consideration of Meeting Minutes

The Board thanked them all for their dedication and service to the state of North Carolina.

The Board then took a short break and reconvened at 11:19 am.

Approval of Protocols Implementing Pharmacist Authority under SL 2021-110

SL 2021-110 created certain new authorities for pharmacists to order, dispense, and administer: (1) certain smoking cessation products; (2) hormonal contraceptives; (3) pre-natal vitamins; (4) post-HIV exposure prophylaxis; and (5) glucagon to treat severe hypoglycemia.

The statute directed the State Health Director (Dr. Betsey Tilson) to implement these authorities by standing order. The statute commanded that the standing orders would stay in effect until the later of January 1, 2023 or the Boards of Medicine and Pharmacy issuing protocols. Dr. Tilson convened a number of meetings among a wide range of stakeholders. In March 2022, she issued standing orders implementing all five authorities. Three of the five remain unchanged. In April 2023, Dr. Tilson made a slight amendment to the hormonal contraceptive standing order to clarify that the required pre-dispensing blood pressure reading could be obtained by any qualified pharmacy personnel, not only the dispensing pharmacist. In June 2023, Dr. Tilson made a slight amendment to the glucagon standing order to specify that a pharmacist contemplating administering (not dispensing) glucagon in an emergency situation should obtain a blood glucose reading to confirm a hypoglycemic crisis if possible.

The Joint Medical-Pharmacy Board Committee to Implement SL 2021-110 met on June 30, 2023. The representatives (Duggins, Corbin, Vance for the Pharmacy Board; Khanderwal, Rusher, Sangvai for the Medical Board) unanimously agreed that the standing orders safely and appropriately implement the new SL 2021-110 authorities. The Joint Committee recommended that the Medical and Pharmacy Boards formally adopt them as protocols. The Board of Pharmacy will be responsible for publishing the protocols and updating pharmacists. Mr. Campbell commended Duggins, Corbin, and Vance for their hard work and also Dr. Tilson for bringing together a wide range stakeholders to obtain agreement on the standing orders.

Mr. Nelson moved to adopt all five standing orders as protocols. Ms. Corbin seconded. The motion passed unanimously.

The Medical Board is scheduled to take up protocol adoption at its July 2023 business meeting.

Financial Reports

May Financial Report (*Brown*)

The members received the monthly financial report prior to this meeting. The members reviewed and had no questions. Mr. Brown reminded the Board that the annual financial audit will occur the last week of August 2023.

Licensing Report (Betz)

Missy Betz, Director of Licensing, reported that the first Intern Registration renewal will begin on August 1st and end on August 31st. Guidance will be sent out to the schools of pharmacy this week, and reminders to all currently registered interns will be emailed on August 1st.

<u>Investigations and Inspections Report</u> (Wiesner)

Loretta Wiesner, Director of Investigations, presented the investigations report and current caseload.

<u>Legislative Report</u> (Pinyan, Campbell)

<u>H.190 (SL 2023-65)</u>. H290 was an omnibus Health and Human Services update bill. It included several provisions that related to pharmacy practice:

The law extends State Health Director Betsey Tilson's authority to issue standing orders on COVID vaccination and treatment through December 31, 2024. This aligns Dr. Tilson's authority with the PREP Act declaration extension.

The law adds gabapentin to the list of substances whose dispensing must be reported by pharmacists to the North Carolina Controlled Substances Reporting System. The law exempts reporting of gabapentin that is "a component of a compounded prescription that is dispensed in dosages of 100 milligrams or less." This new reporting requirement becomes effective on March 1, 2024.

The law adds "controlled substances included in G.S. 90-93(a)(1)a" to the STOP Act's list of substances that must be prescribed electronically (unless an exception applies). G.S. 90-93(a)(1)a defines as a Schedule V controlled substance "any compound, mixture or preparation containing an of the following limited quantities of narcotic drugs or salts thereof, which shall include one or more nonnarcotic active medicinal ingredients in sufficient proportion to confer upon the compound, mixture or preparation valuable medicinal qualities other than those possessed by the narcotic alone . . . Not more than 200 milligrams of codeine or any of its salts per 100 milliliters or per 100 grams." This includes promethazine with codeine Schedule V products. This new electronic prescribing requirement "does not apply to any product that is sold at retail without a prescription" as allowed by North Carolina law. The electronic prescribing requirement becomes effective on January 1, 2024.

<u>S20 (SL 2023-14)</u>. S20 is the new state law governing surgical and medical abortions. The provisions speaking to medical abortions do impact pharmacy practice. Board staff have been working on a potential guidance document, but the new law is both subject to litigation and has been further amended by SL 2023-65. Board staff are working through S20, amendments to it contained in H190, and the litigation status to provide current information.

<u>S206 (SL 2023-15)</u>. Controlled Substances, Opioid, and Vaccine Omnibus. As the "omnibus" title suggests, this statute has a number of components. Most relevant to the Board:

- (1) Expands the definition of "opioid antagonist" beyond naloxone. At this point, that makes no real practical impact, but it makes provisions speaking to opioid antagonist programs applicable as new products gain FDA approval.
- (2) Expands immunizing pharmacist authority to administer: any ACIP recommended vaccine to a patient age 18 or older pursuant to protocol; Flu and COVID vaccine to a patient age 7 or older pursuant to protocol and parental/guardian consent. Immunizing pharmacy technicians under supervision may administer flu and COVID vaccine to patients 7 or older.

- (3) The bill would require the Pharmacy and Medical Boards, upon recommendation of a new vaccine by ACIP, to review and update protocols "as needed." Unless and until the boards chose to make any changes, immunizing pharmacists could administer the new vaccine under the ACIP recommendation. Board staff have already published guidance to this new authority.
- <u>S.69/H287</u>. Educate Patients About Opioid Antagonists. The bill would require a prescriber, when issuing a prescription for an opioid to provide information to the patient about potential opioid danger, overdose prevention, and the availability and use of FDA-approved opioid antagonists to reverse opioid-induced respiratory depression. Pharmacists would be required, when dispensing an opioid pain medication, to ask whether the patient has a prescription for an opioid antagonist and, if so, offer to fill it; if the patient lacks an opioid antagonist prescription, offer to dispense one pursuant to the statewide standing order for naloxone; provide the same information to the patient that the prescriber is required to provide (and noted above). July Update: No movement.
- <u>H125 Omnibus Health-Related Matters</u>. This bill now incorporates a number of provisions previously found in other bills. Most pertinent:
- (1) Modifications to optometry laws (previously in S659). Contains provisions clarifying dispensing authority for optometrists, oversight by the Pharmacy and Optometry Boards, and registration with the Pharmacy Board. Limits eligible drugs to those to treat abnormal conditions of the eye and its adnexa.
- (2) Expand ability for pharmacists and physicians to enter into collaborative practice agreement (previously in S597). This bill would broaden the ability of pharmacists to enter into collaborative practice agreements with physicians to provide "health care services," a broader term than in existing CPP authority. That term is defined as "medical tasks, acts, or functions authorized through a written agreement by a physician and delegated to a pharmacist for the purpose of providing drug therapy, disease, or population health management for patients." Authorizes site-specific, multi-provider collaborative practice agreements. Authorizes NPs and PAs to be a part of a collaborative practice agreement. Simplifies physician oversight requirements. Pharmacy and Medical Boards would be required to do joint implementing rulemaking.

This has passed House and Senate. Presently calendared for a House concurrence vote on July 12, 2023. Board staff reached out to key sponsors to communicate the Board's long-standing support for collaborative practice expansion.

<u>H.75/S47</u>. Physician Assistant Team-Based Practice. Versions of this bill were introduced and passed by each chamber last year. It was reintroduced in substantially the same form as last year's House version. Noteworthy again is that the bill makes changes to physician assistant dispensing authority. Mr. Campbell had concerns last year that the legislation arguably removed dispensing physicians from oversight by the Board of Pharmacy. He communicated that concern to Representative Sasser, who successfully introduced amendments that

explicitly preserve that authority. The bill passed the House unanimously on February 22. The Senate attached a rider that said the bill would become effective when and if S3 (the medical marijuana bill) passes the House. July Update: No movement.

<u>S.3</u>.Compassionate Care Act. This is the reintroduction of the medical marijuana bill that passed the Senate last session, but made no headway in the House. July Update: Passed the Senate, 36-10, on March 1. Received in the House and referred to House Rules Committee. Now sitting in House Health.

<u>H.654</u>. Pharmacists/Vaccine Administration/Test and Treat. Authorizes pharmacists to order a CLIA_waived to test to assist with clinical decision making related to the use and monitoring of medications and to treat flu, COVID-19, Strep A, or other health conditions screened by utilizing a CLIA-waived test. It was introduced on April 17 and now referred to House Health. July Update: No movement.

<u>H.576</u>. Health Care Transparency Act. The in periodic fights over "who can be called doctor." It continues to sit in Senate Rules Committee.

Rulemaking (Pinyan, Campbell)

For Action by the Board:

Proposed Adoption of 21 NCAC 46.1821, Direct to Patient Dispensing Systems

Proposed Adoption of Amendment to 21 NCAC 46.1816, Limited-Service Permits

The Board noticed a proposed adoption of new rule 21 NCAC 46.1821 to authorize and regulate the use of direct-to-patient dispensing ("DTP") systems by pharmacies. The Board also noticed an amendment to 21 NCAC 46.1616, which authorizes and regulates limited-service permits, to include DTP system sites as pharmacies eligible for a limited-service permit.

The public comment period closed at 5 pm, Friday, June 16, 2023. The Board received three written comments. The Board heard verbal comments from one member of the public at a Tuesday, June 13, 2023 hearing. All written comments were directed toward Proposed Rule .1821. None commented on the proposed amendment to Rule .1616.

The Board's Telepharmacy Committee reviewed and discussed each of the received comments and has recommended adoption of the rules as published. The Board remembers received the Committee's recommendations and reasons for the recommendations.

Mr. Campbell explained that the rule was before the Board eligible for action. Mr. Nelson moved that the rule be approved as written and was seconded by Dr. Sain. The motion passed unanimously.

Board Counsel Clint Pinyan will shepherd the new and amended rules through the Rules Review Commission process.

Working Group members discussed a number of topics, and focused on potential amendments to the satellite permitting provisions and validating technicians provisions. The Committee will convene again during the Board's October 2023 workday.

Patient Counseling Rule Review – *Duggins, Vance, Bowman* (members); *Campbell, Pinyan* (staff)

Board staff has drafted a preliminary discussion draft of potential amendments to the rule for the committee's consideration.

S.L. 2021-110 Implementation (New Practice Authorities) – *Duggins*, *Corbin, Vance*, (members); *Campbell, Pinyan, Vick* (staff)
The Board's designees to the joint S.L. 2021-110 Pharmacy-Medical Board
Committee met with their Medical Board counterparts in late June. The Joint
Committee unanimously agreed to recommend that both boards adopt the current SL 2021-110 standing orders as protocols.

Mr. Campbell reminded the Board that, with their prior approval, he had signed the contract on their behalf to extend BOP financial support for required hormonal contraceptive training.
