Ethics Statement & Welcome

President Bowman read the Ethics Statement regarding conflicts of interest and/or appearances of conflicts of interest of any Board member. No conflicts were noted by Board members.

Consideration of Minutes of the July 2018 Meeting and the September 13, 2018 Board Meeting Conference Call

The members received the July 17, 2018 meeting minutes prior to this meeting for review. It was moved by Mr. Graves, seconded by Mr. Minton, to approve the minutes as submitted. The motion passed with no dissenting votes.

Welcome to New Board Member Ashley Duggins

At the July 2018 Board meeting, Ashley Duggins was elected by Board Members as the new Board member for the Central District after the passing of Board Member Stan Haywood. Mr. Campbell welcomed Ms. Duggins to the Board.

Update on Hurricane Florence

Mr. Campbell stated that staff has taken many measures to support pharmacies in dealing with public health concerns attributed Hurricane Florence. This includes waivers of the certain Pharmacy Practice Act requirements approved by the Board at the September 13, 2018 conference call to ensure patients' needs are being met through the public health issues created by the hurricane. He thanked Board Members and Board staff for the efforts and gave a special thanks to Amanda Fuller Moore, DHHS, and John Stancil, Division of Medical Assistance.

Review of Ashley Duggins Ethics Evaluation Letter

The State Ethics Commission had reviewed the Statement of Economic Interest filed by new Board Member Ashley Duggins. The commission found no actual conflict of interest but did

caution (as it has with every pharmacist member) about the potential conflict of interest by serving on a licensing board for members of her own profession.

Petition for Approval of License Application, Jason W. Konst

RPh. Jason Konst appeared before the Board on his petition for approval of his North Carolina application for pharmacist licensure by exam. Dr. Konst disclosed on his application that, in November 2015, while working as a pharmacy intern, he admitted to South Carolina DHEC investigators that he was using alprazolam that had not been prescribed for him.

Dr. Konst surrendered his South Carolina pharmacy intern license and was referred to the South Carolina Recovery Professional Program (SCRPP). He completed thirty (30) days of inpatient treatment and sixty (60) days of outpatient treatment for substance abuse and remained under the monitoring of the SCRPP.

In December 2016, the South Carolina Board of Pharmacy reinstated his pharmacy intern license, he resumed pharmacy school, and ultimately graduated. Dr. Konst became licensed as a pharmacist in South Carolina but per his South Carolina intern license reinstatement order, he is on probation for a period of four years.

In February 2018, Dr. Konst enrolled in a program with NCPHP. Joe Jordan, NCPHP, duly sworn, provided a positive evaluation of Dr. Konst's recovery.

After discussion and presentation of evidence, on a motion from Mr. Vance, seconded by Mr. Minton with no dissenting votes, the Board would allow Mr. Konst to proceed with licensure in North Carolina. If he successfully completes the application process, then his license will be suspended, but that suspension will be stayed with conditions.

A copy of the Final Order of Discipline can be found elsewhere in the Minutes and is incorporated by reference herein.

The Board adjourned for a break at 10:47am and resumed open session at 10:58am.

Consideration of Walgreens, Permit #12259, Request for Tech Ratio Increase

The Board has instructed Board staff that a request for increase to a technician:pharmacist ratio of 3:1 or 4:1 may be allowed by staff without formal Board action so long as the pharmacy demonstrates that it employs sufficient certified technicians to meet the ratio. The Board has directed staff to refer any request for a 5:1 or higher ratio to the full Board for consideration.

Walgreens, permit #12259, submitted an application to increase their technician:pharmacist ratio to 5:1. Pharmacist Manager Barbara Gilbride, license #12259, appeared before the Board to explain the reasoning for their request.

After discussion, a motion was made to approve the application. The vote on that motion was 3-3, meaning the motion did not pass and the application was not granted. Board members stated

that, given the stores high prescription volume and high vaccination volume, they found unacceptable public safety risk in a pharmacist conducting those activities and supervising up to five technicians.

Inquiry Concerning Prescription Drug's Country of Origin on Patient Labeling

Robert LeBlanc of Southport, NC, sent a series of email to Board Executive Director Jay Campbell and the Food and Drug Administration (FDA) regarding his concern that the prescription label of any prescription dispensed by a North Carolina pharmacy state the "manufacturer name and country of origin."

After discussion, the Board members instructed staff to contact Mr. LeBlanc to explain that his concerns would be best handled by the state legislature and he should contact his local representative.

Staff Proposed Changes to Pharmacy Permit Application Process

Missy Betz, Director of Licensing, presented proposed changes to the permit application process. The Pharmacy Practice Act states that permits are issued to the pharmacy manager on the permit application and they are held responsible for the permit. Ms. Betz stated that in order to streamline the permit application process and reduce the number of calls regarding a permit application, staff would like to require that the permit application be only submitted by the pharmacist manager of an original permit application.

After discussion, it was the consensus of the Board to approve the requested change.

Board staff also requested approval from the Board to inactivate the "original" Pharmacy permit during the application process of a Transfer of Ownership application or Re-Registration application, if the change has already occurred. Permits are issued to specific permitted location and the original permit would no longer be valid if the facility has already moved location.

After discussion, it was the consensus of the Board to approve the requested change.

The Board adjourn for lunch at 12:00pm and resumed open session at 12:45pm.

Mr. Minton was not present for the remainder of the meeting.

Proposed FY2018-19 Budget, As Recommended by the Budget and Finance Committee

JP Brown, Accounting Manager presented the proposed budget for the 2018-19 fiscal year as recommended by the Board Finance Committee (Graves and Bowman,).

Mr. Campbell stated that the Board Finance department will adjust the next fiscal year to run October 1, 2018 to June 30, 2018 to synchronize the Board's fiscal year with the state's fiscal year.

After discussion, on a motion from Dr. Vance, seconded by Dr. Bowman, with no dissenting votes, the Board approved the budget as presented.

Mr. Brown also presented the July 2018 financial report to the Board.

Investigative Statistics

Krystal Stefanyk, Director of Inspections, presented the September 2018 investigative report. Joshua Kohler, Director of Investigations stated that Board staff is going to conduct random site visits of pharmacies affected by the hurricane to offer any help or guidance that they may need.
