

President Andy Bowman called the meeting to order at 10:01 am with Board Members Mischelle Corbin, Ashley Duggins, Wallace Nelson, Chris Sain, and Keith Vance present.

Also in attendance were Executive Director Jay Campbell, Board Counsel Clint Pinyan, Associate Executive Director Ellen Vick, Director of Inspections Krystal Stefanyk, Director of Investigations Loretta Wiesner, Director of Licensing Missy Betz, Director of Finance and Human Resources Rhonda Jones, Director of Operations Kristin Moore, Information Technology Administrator Antoine Pryor, Enforcement Specialist Joshua Kohler, Enforcement Specialist Cindy Parham, Senior Investigator/Inspector Holly Price Hunt, Senior Investigator/Inspector Jason Smith, Investigator/Inspector Brent Slaughter, Investigator/Inspector Jimmy Fickling, and Administrative Assistant Leslie Wilson.

#### Ethics Statement & Welcome

President Bowman read the Ethics Statement regarding conflicts of interest. No conflicts were noted by Board members.

#### Consideration of Meeting Minutes

The members received the July 11, 2023 meeting minutes for review prior to the meeting. Ms. Corbin moved to approve the minutes. Mr. Wallace seconded. The motion passed unanimously.

#### Presentation to the Board on NP/PA Dispensing Oversight (*Timbo Taylor, M.D., Mainstreet Family Urgent Care*)

Timbo Taylor, MD, and the Medical Director of Mainstreet Family Urgent Care, addressed the Board concerning oversight of PA/NP dispensing sites. Dr. Taylor asked the Board to consider whether the present requirement that the pharmacist-manager make an in-person visit to a PA/NP limited service permit each week could be broadened, with more of the supervision performed remotely.

Mr. Campbell suggested the Board take this up for discussion at the November retreat and the Board agreed.

#### Hearings

##### Disciplinary Hearing, Jilyan Billingsley, License #26514 (*Pinyan*)

On October 18, 2022, the Board of Pharmacy summarily suspended Dr. Billingsley's license. On February 14, 2023, the Board of Pharmacy reinstated Billingsley's license pursuant to an agreed order in which, among other things, required Dr. Billingsley to submit to quarterly random drug testing for three years. On June 24, 2023, Dr. Billingsley submitted a drug screen upon request by Board staff and tested positive for marijuana. Dr. Billingsley scheduled an initial screening appointment with NC Professionals Health Program ("NCPHP") for August 10, 2023. The day before the appointment, she cancelled it.

Mr. Pinyan called Director of Investigations Loretta Wiesner and NCPHP CEO Joe Jordan for direct testimony. They were also questioned by Dr. Billingsley's counsel, Nick Dougal. After receiving testimony and evidence from Dr. Billingsley, and receiving evidence from Board Counsel Clint Pinyan, Dr. Vance moved for a closed session to deliberate. Ms. Corbin seconded. The motion passed unanimously at 11:15 am.

The Board returned to open session at 11:43 am. President Bowman issued the Board's decision that Dr. Billingsley receive an assessment from NCPHP in the next 14 days. If she fails to do so, or the results of the assessment indicate that Dr. Billingsley cannot practice pharmacy with safety and competency, she will be noticed to appear before the Board again for potential suspension or revocation of license.

Petition for Lifting of Pharmacist-Manager Restriction, Nathan Long, License #25459 (Campbell)

Dr. Long came before the Board to request the lifting of a restriction prohibiting him from acting as a pharmacist-manager. Mr. Jordan testified that NCPHP supported this modification to Dr. Long's reinstatement order. Mr. Nelson motioned to approve Dr. Long's request and was seconded by Ms. Corbin. The motion passed unanimously.

The Board then adjourned for lunch at 11:55 am and reconvened at 12:50 pm.

Financial Reports

Director of Finance and Human Resources Rhonda Jones presented the monthly financial report. The members received the report prior to this meeting. The members reviewed and had no questions.

Process for Review and Approval of FY 2022-2023 Financial Audit (Campbell)

The annual financial audit report will be received in early October and must be included with the Chapter 93B Annual Report that is due on October 31. With no Board meeting in October, Mr. Campbell asked that the Budget & Finance Committee be authorized to review and accept the fiscal audit report on behalf of the full Board.

Mr. Nelson moved to authorize the Budget & Finance Committee to review and accept the FY 2022-2023 audit report on behalf of the full Board. Dr. Duggins seconded. The motion passed unanimously.

#### 2024 Board Meeting Schedule (Moore)

Kristin Moore has prepared a proposed calendar of meetings for 2024. The proposed calendar retains the current meeting cadence – second Tuesday of January, March, May, July, and October for Board business meetings, with one exception. The May 2024 meeting is calendared one week later – May 21 – to avoid a conflict with the NABP Annual Meeting.

Prehearing Conference days schedule for the second Monday of January, February, March, April, June, July, September, October, and November. PHC day is scheduled for May 20 to avoid a conflict with the NABP Annual Meeting. Board committee workdays are scheduled for the second Tuesday of February, April, June, and October.

Mr. Nelson moved to approve the calendar and Dr. Duggins seconded. The motion passed with no dissenting votes.

#### Implementation of SL 2021-110 Protocols (Campbell)

The Board of Pharmacy adopted State Health Director Betsey Tilson's SL 2021-110 standing orders as permanent protocols at its July meeting, as recommended by the Joint SL 2021-110 Implementation Committee. The Medical Board followed suit the following week. The protocols and a detailed guidance document have been published.

#### Licensing Report (Betz)

##### Pharmacy Intern Renewal Report

Director of Licensing Missy Betz reported on the first Pharmacy Intern Renewal. 1086 interns renewed and all went smoothly. Licensing Specialist Stacie Mason did the lion's share of the renewals and was commended for her work.

##### 2024 Pharmacy Permit Renewals

Ms. Betz updated the Board on modifications to the compounding services questionnaire for 2024 pharmacy permit renewals, as well as the programming underway to modify the pharmacy services questionnaire and limited service permit application to account for new rule 21 NCAC 46.1821, Direct to Patient Dispensing Systems

#### Investigations and Inspections Report (Stefanyk)

##### Investigative Statistics (Stefanyk)

Krystal Stefanyk, Director of Inspections, presented the investigations report and current caseload.

Introduction of New Investigator (*Wiesner*)

Mr. Campbell expressed his appreciation for Director of Investigations Loretta Wiesner and all that she has accomplished in her years of service at the Board of Pharmacy. Ms. Wiesner shared gratitude to Mr. Campbell, the Board and staff for the past thirteen years. She then introduced James (Jimmy) Fickling as the new investigator/inspector for the southeastern region.

Legislative Report (*Pinyan, Campbell*)

Different versions of H125 passed the North Carolina House and Senate. On July 12, the House appointed Representatives Potts, White, Baker, and Sasser to a conference committee. On August 10, the Senate appointed Senators Sawrey, Rabon, and Hise. The Board accepted Mr. Campbell's offer to send another letter to the sponsors of the bill in support of the Senate's version of the collaborative practice expansion.

The Pharmacy and Medical Boards adopted the implementing state protocols. Board staff have published guidance.

Telepharmacy Committee – *Vance, Bowman, Nelson* (members); *Campbell, Pinyan* (staff)

Mr. Campbell expressed his appreciation to both past and present members of the committee for their work on Remote Medication Order Processing expansion and revision; and most recently on issues surrounding direct-to-patient automated dispensing technology.
