Item 1168 – Important Renewal News

Again this renewal year, the North Carolina Board of Pharmacy staff will utilize electronic renewal of licenses to practice pharmacy as the primary method of renewing individual active pharmacists who reside in the US. This is a secure site and all personal and financial data is protected. No pharmacist renewal applications will be automatically mailed as in the past. The renewal process begins on November 1 and pharmacists should go to the Board's Web site, www.ncbop.org, and follow the prompts under "Electronic Renewals." An immediate confirmation is available for online renewals. Certificates will be mailed within approximately three days of the online process. Deborah Stump at the Board office (dstump@ncbop.org) is the "go-to" person

Beginning this renewal year, the electronic process will also be used for renewing Devices and Medical Equipment (DME) permits, and the "go-to" person for this task is Melanie Hawn (mhawn@ncbop.org).

The paper process for renewal is still available for pharmacists and DME permit holders, however, the processing time is expected to take at least three to four weeks for these applications. You may download renewal forms from the Board's Web site at www.ncbop.org in the "Downloadable Forms" section on the home page. Renewals of permits to operate pharmacies will be handled on a paper basis until a procedure is developed in the future for electronic renewals.

Item 1171 – Continuing Education

Recent events have caused some pharmacists to go into active duty in the armed forces, as many did during Desert Shield/Storm more than 10 years ago. Under these circumstances the members of the Board have instructed staff to consider continuing education waivers for people who are on active duty outside of the United States on an individual basis.

At the same meeting the members decided that academic programs leading to a masters in business administration are not acceptable for continuing education.

Item 1172 – Charitable Drugs

Pharmaceuticals provided by manufacturers through a charitable program or obtained for use in "free clinics" need to be handled in the same way as any other similar item in commerce. In other words, prescription drugs being sent by or on behalf of manufacturers to patients need to be as properly packaged and labeled as any other prescription drug. This process needs to occur at a location with a pharmacy permit in the same way as any other out-of-state pharmacy.

There is no exemption for the packaging, labeling, record keeping, patient counseling, and drug utilization review requirement for these products.

Item 1173 – Patient Counseling Detects Mistakes

Andrea Ellenburg reported an incident to the Board office that highlights the importance of patient counseling. She received a handwritten order for two drugs that looked like orders for Amoxil and Parafon Forte. During her counseling of the patient she learned that the physician intended one of these prescriptions to drain sinuses. In speaking with the physician she learned that the prescriber intended to write "Profen Forte," and Parafon Forte would have had an entirely different and unintended result.

Patient counseling will save lives.

Item 1174 – Valid DEA Number Required On Pharmacy Prescriptions

The Division of Medical Assistance (DMA) requires Drug Enforcement Administration (DEA) numbers on all recipient pharmacy claims. Providers must have their DEA registration number on file. Failure to do so may result in denied claims.

If a prescriber does not have a DEA number, yet provides prescriptions to Medicaid recipients, the prescriber will need to contact the Drug Use Review (DUR) Section at 919/733-3590. This specifically includes Clinical Pharmacist Practitioners.

The DUR section will issue a prescriber Medicaid identification (ID) number in lieu of the DEA number. The ID number, following the same format as the DEA number, will always begin with a Z (for example, ZF1234567). Prescribers will need to enter this number on their Medicaid prescriptions. This number is referred to as a **prescriber Medicaid identification number** only and should not be referred to as a DEA number.

An accurate DEA or ID number on Medicaid prescriptions is mandatory. DMA relies on this for effective recovery of third party payments, DUR, fraud and abuse, and the cost containment.
